

# Tarporley Community Centre - Buy a tile for £10!

Our heavily used Community Centre is in need of some TLC! Most of the roof is 60 years old and the leaks are getting more frequent and difficult to repair. A new roof is needed!

The anticipated cost of the project is expected to be in the region of £100,000 including the new tiles, battens, felt, insulation and acoustic tiles for the hall ceiling.

We intend to put in £30,000 from our reserves so around £70,000 needs to be raised.

As around 7,000 new tiles are required this means that the installed cost of each tile will be £10.

**Hence buy a tile for £10 each!**
